- (3) Grant/Decline a Heritage Grant in the amount of \$ for Luhrs Cottage Preservation Society to go towards the repairs to exterior of cottage, painting of shed and fence and gate for the property located at 407 Light Pass Road, Light Pass.
- (4) Grant/Decline a Heritage Grant in the amount of \$ for James Ehrat to go towards the replacement of a leaking rusty roof on barn at 224 Krondorf Road, Tanunda.
- (5) Grant/Decline a Heritage Grant in the amount of \$ for Heidi Helbig to go towards the treatment of damp course on stone wall for property located at 2 Bethany Road, Tanunda.
- (6) Grant/Decline a Heritage Grant in the amount of \$ for Eden Valley Congregational Community Centre Inc to go towards repair work to rendering of walls for the property located at Matthews Road, Eden Valley.
