TENDER – DESKTOP REFRESH RFQ (2014/01)

REPORT:

The matter of the agenda item being a tender for the supply of goods, the provision of services or the carrying out of works which, pursuant to Section 90(3)(k) of the Local Government Act 1999 being information to be considered in confidence to protect commercial information provided through the tender process.

- (1) Under the provisions of Section 90(2) of the Local Government Act 1999, an order be made that the public be excluded from the meeting with the exception of the Chief Executive Officer, Acting Director Corporate and Community Services, Manager, Knowledge and Technical Services, ICT Application Specialist and the Minute Secretary, in order to consider in confidence a report relating to Section 90(3)(k) of the Local Government Act 1999 – Tender – Desktop Refresh RFQ (2014/01) being tenders for the supply of goods, the provision of services or the carrying out of works to protect commercial information provided through the tender process; and
- (2) Accordingly, on this basis, the principle that meetings of the Council should be conducted in a place open to the public has been outweighed by the need to keep the information and discussion confidential.
