ELIGIBILITY CRITERIA

Council may, on application, consider granting a rebate of that portion of general rates (excluding fixed charge) where the increase in the amount payable **is greater than 7.5%** from the 2025/2026 rating year in respect of an assessment, provided that the following criteria are satisfied:

- a is the property for which you are making application for rebate your principal place of residence? YES / NO
- b has the property been your principal place of residence since at least 1st July 2025 (ratepayers moving into the property after that date do not qualify for the current year) YES / NO

If you have answered 'NO' to a or b above, the rebate is not available

- c have any improvements been made which would affect the capital value of the property? YES / NO
- d is any commercial/industrial activity being carried out at the property? YES / NO
- e is the property related to the principal place of residence for the purposes of single farm enterprise and/or contiguous land? YES / NO
